6. KMS Report

KMS Principal, Tina Chahanovich presented to the Board, a report, primarily focusing on student emotional and social learning at KMS. Teachers continue to learn practical PBIS and Responsive to Intervention strategies to create a positive learning environment. Student office referrals have

decreased when compared to last year. KMS created a "Look for the Good Campaign" to promote positive school climate. The two-week campaign encouraged students to be kind, respectful, and grateful. Guided by teachers, student shared their "*highs and lows*" in their classroom. KMS teachers participate in responsive classroom training, behavior coaching and teacher book studies. Much of KMS's professional development focuses on strategies for supporting children's social and academic learning, developing positive student behavior, which makes it easier for students to focus on their academics.

Mr. Steven Rioux shared proposed 2019-20 school year tuition rates for KHS, KIS, KMS, and KCS and explained how tuition rates are calculated. Operational cost, capital cost, bond rates and the number of students are components of calculating tuition rates. The rates reflected on the handout include a tuition rate of \$15,523 for KHS, \$11,943 tuition rate for KIS and \$10,400 tuition rate for KCS and KMS. The 2019-20 tuition rates will be applied to F1 students and students from other sending districts.
