Karen Greene a resident and seventeen-year para is upset about negotiation impasse. They are being asked to sub for teachers leaving gaps in their roles and responsibilities. They are simply asking for a living wage toe restore the numbers of paras in the district and ultimately the reputation of the Board for supporting their employees.

10.F REPORT OF 2020-2021 STATE ASSESSMENT RESULTS

Dr. Nash presented on the State Assessments (SBAC, NGSS, and School SAT Day). She reminded the Board the numbers would represent children educated in the hybrid model. For students who participated in full remote learning, they were reported separately and not included in these numbers. In this assessment period, our highest need students saw significant gains scoring above the state average in science and ELA. Killingly has decided to use a strategy called acceleration to help with the gaps in learning seen during the last 18 months. ESSER funds have been used to hire math and ELA tutor and coaches to use acceleration in the classroom with students. A Board member expressed concern with our children paying the price for the disconnect between curriculum implementation, training and teaching.
